- Leadership scores are consistently lower than other metrics across most companies, suggesting an industry-wide opportunity for improvement.
- Work-Life Balance appears to be a relative strength for many companies in the industry, with five firms scoring above 60.
- Firms with higher integrity scores (Lockton, Alliant, USI) tend to have stronger overall resilience regardless of other metrics.
